Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct test. Dogs completing the RATN Open in the next trial and still participate in Instinct for the remainder of event weekend. This is up to the handler and not required. Move-ups will be accepted in writing at the secretary table until 30 minutes prior to the next trial. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. Pay Pal is available via invoice only. Refunds minus actual processing fees may be requested until closing date, no refunds will be made after closing date. All refunds will be via pay pal. Safety

All Dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTTED INISDE ANY BUILDINGS. No e-collars, or head-halters allowed. There is **no smoking** in the barns or within 20' of any entrance. Smoking is restricted to paved roadways only or as determined by the venue. Please pick up after your dog and dispose of waste in appropriate containers outside of the barns. Failure to do so may result in disciplinary action. Barns are covered but not climate controlled, plan accordingly. There are designated crating areas in the barn. Disruptive dogs may be requested to stage in their vehicle.

Running Order

Dogs will be run in height order with dogs being handled by the same person separated into different blinds, order will be announced when trial closes & Wednesday before the event.

Awards

No awards, other than those are listed within this premium list will be given. Ribbons will be awarded for 1st through 4th place in each height division for each regular class. Dark Brown qualifying ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. High in class Rosettes will be offered each trial by RiverRat Barn Hunt. New Title Rosettes for RATN, RATO, & RATS. Special rosettes and for RATM, RATCH, and RATCHX. All awards must be picked up that day, none will be mailed.

Bitches in season

Are eligible for entry but will be required to be kept separate from all other dogs and will run in panties at the end of their class/trial. If bringing a BIS, please inform the trial committee and all exhibitors at the judges briefing.

Refunds: Full refunds minus actual processing fees via PayPal prior to closing, no refunds after closing.

UKC Events

Cascade American Pit Bull Club is hosting conformation, weight pull, and junior showmanship competition in the main barn. The BHA trial grounds are the ring and blind area, and 20' around those areas. BHA LLC rules apply within trial grounds which will be marked. To participate in the UKC events your dog must be registered with UKC or have a temporary listing number.
